#### OUR SUCCESS

- We are successful when
- Health and Safety: No one gets hurt. Zero LTI
- Environment: Nil significant environment incidents
- Communities/Stakeholders: Obligations met, no disruption to operations
- Production: Copper metal ≥110,000 tonnes, ≥Gold 300,000 oz
- Financial: Gross revenue ≥US\$1,000M+
- Mining: Cost ≤US\$2.15/t ex-pit
- Processing: Cost ≤US\$6.50/t milled (excluding Bige)
- General & Admin: Cost ≤US\$11.5 M/month
- Sustaining CAPEX: ≤US\$50Mpa delivered on time, on budget, benefits realised

- Reporting all incidents and injuries, including Near Misses, to your Supervisors

- Report ALL environmental incidents and Near Misses to your Supervisor immediately






### **Achieving Success Means -**

#### DO ...





- Wear the appropriate PPE
- Keep workplaces clean and tidy
- Use safety tools JSO, JSA, Hazard Identification
- Observe your workmates:
  - Intervene if they are working unsafely
  - Recognize them if they are working safely
- Report all safety & environment incidents or near misses
- Look out for signs of fatigue
- Add a SHE moment to start every meeting
- Share your experiences to assist others
- Identify and report hazards speak up
- Follow up on commitments

#### **DO NOT** ...



- Start a job without understanding how to do it safely
- Take short cuts
- Operate a vehicle without a licence / permit
- Litter or leave trash for others to clean up
- Start a job without thinking what could go wrong
- Walk on by a potential accident
- Expose yourself or others to hazards
- Hide mistakes
- Get insufficient or irregular sleep
- Assume you know everything
- Remain silent on safety/environment issues
- Wait for a safety meeting before acting
- Let others down
